Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. Form HUD-50075-SM is to be completed annually by **Small PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, HCV-Only PHA, or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

It will determine an amount of applications to accept based on its administrative capacity and the estimated time it would take an applicant to reach the top of the waiting list. Applications will be accepted online during the waiting list lottery enrollment period. After the end of the lottery enrollment period, accepted applications will be randomized and the predetermined amount of names will be selected to be placed on the waiting list in randomized order.</p> <p>MCHA will allocate up to 10 housing choice vouchers to operate a “Moving On” program. It will open a separate waiting list with a preference for individuals and families transitioning from Permanent Supportive Housing units of a McHenry County Continuum of Care agency. Only applicants meeting this preference will be placed on the Moving On waiting list.</p> <p>MCHA will allocate 5 housing choice vouchers to operate a “Housing First” program. It will open a separate waiting list with a preference for chronically homeless individuals and families that are working with Thresholds, a McHenry County Continuum of Care agency that provides housing and mental health services for chronically homeless families and individuals. Our commitment of vouchers allows these developments become more competitive in securing their financing. MCHA purchased an 8 unit building in Woodstock and its units will remain affordable to low income tenants.</p> <p>PHA GOAL: MAINTAIN THE QUALITY OF ASSISTED HOUSING MCHA will continue to enforce its "No Smoking Policy" in its housing units to provide a better quality units for its residents. It will continue to use the Capital Fund Program to ensure the Public Housing Units are rehabilitated and modernized as needed. All of the units have been inspected for lead based paint and lead hazard control efforts were implemented.</p> <p>PHA GOAL: INCREASE ASSISTED HOUSING CHOICES The use of Project Based Vouchers increases the choice of assisted housing in McHenry County. The scoring system for allocation of the Project Based Vouchers includes consideration of location in proximity to employment opportunities, good schools, transportation, healthcare facilities, shopping and recreation areas. It will enter into a HAP for these units upon completion. The PBVs will be available for disabled veterans for this project located in an area that is close to schools, employment and transportation. MCHA will enter into an AHAP and HAP for PBVs for 7 units at Cary Senior Living, a new development located in an opportunity area. Both of these developments will further MCHA's efforts to deconcentrate vouchers as they are located in low poverty census tracts. MCHA may issue a request for proposals or rely on another local government competition to award project based vouchers to be located within McHenry County, in HUD identified opportunity areas. The maximum number of PBVs under a new RFP would be 40.
